Reflections on Tradition and Concept:

Catherine S. arrived later, and offered her reflection on Tradition 5, to be included in the minutes.

Tradition 5

Each Al-Anon family. group has but one purpose: to help families of alcoholics. We do this by practicing the 12 steps of AA ourselves., by encouraging and understanding our alcoholic relatives, and by welcoming and giving comfort to families of alcoholics.

Keeping the focus on the helpful tools the program offers me has helped me grow a better perspective in helping my addictive family members, instead of judging their behavior--the solutions rather than the problems. Knowing that the tools have helped millions of others to deal sensibly with similar issues has helped me feel less alone and victimized by the disease. The tools and shares of others have given me courage and hope to find higher ground when things got dicey, and I wanted to get judgey.

I qualify for ACA, Al-Anon, and CODA. I was spared the substance genes by the grace of HP.

Learning to be comforted by others has been a grace for me. It seems HP's way is showing us how comfort works by learning to offer it to others so we

can "taste" it. I had to learn to receive compassion, unfamiliar as it was, before I could practice it with others. Slowly I learned how nourishing it felt so I wanted to share it with others. Al-Anon tools and shares are rich in perspective--the "been there done that" makes my hula hoop feel full of wise company and even priceless serenity ,just knowing you all know this beat and have wisdom to offer me

A wonderfully nurturing atmosphere is created when people help other people by sharing their own experiences. I will contribute to this interchange today. We meet as equals and help one another, not because some are experts and others are learners, but because we all have needs and strengths. Thanks for being here for yourself and for all of us.

The rights of appeal and petition protect minorities and insure that they be heard.

"Concept Five contains the spiritual principle that all opinions must be heard in order to have an informed group conscience. It tells us that even though we might not have unanimity at all times, we agree to listen to everyone's opinion respectfully—especially when there is a minority of only one or a few. It assures us that we have a right to voice our opinions, even if it's the minority opinion. In return, members with a minority viewpoint agree that, having been heard respectfully, they agree to respectfully accept the decision of the group conscience and let go. Concept Five ensures harmony through full participation, building on the wisdom of Concept Four. It is not intended to justify bitter debate that never ends."

From Reaching for Personal Freedom note: The importance of minority opinions, and respectful listening are emphasized in this Concept.

- Three minutes at the microphone. During discussions, limiting our time at the microphone embodies the spiritual principles of humility and trust.

- Stay on topic. The spiritual principle of simplicity, while we stay on topic, will help us reach our primary goal to help families and friends of alcoholics.
- Please raise your hand should you wish to say something. If someone before you says what you were going to say ... sit down. Spiritual principles: efficient leadership and awareness.
- No clapping, cheering, or booing, when opinions are shared demonstrates mutual respect and creates an atmosphere of harmony.
- No side conversations. The spiritual principle of courtesy is shown when we actively listen and form our own conclusions, leaving out reactions, opinions, and judgments.
- No miscellaneous distractions. Show discipline and respect for the service commitments of those who have prepared for the District Meeting.
- Keeping our cell phones off demonstrates consideration for those around us as we focus on our District.
- If you are unable to attend a session, notify the District Representative or alternatively the District Secretary. Our spiritual principles of selflessness and dedication are evident when we do the right thing and are responsible to those we serve. Keeping an accurate count of members present at our District meeting is essential during voting.
- Practice spiritual principles and presume goodwill. By practicing humility, harmony, and unity, we can reach our ideals.
